## 2019 Taiwan Patent and Trademark Filing Statistics

Based on statistics reports from the Taiwan Intellectual Property Office, there was a modest increase in both patent and trademark applications of 2019. In total, 74,652 patent applications were filed, representing an overall increase of 1.67%. Among three types of patent applications, invention cases were increased by 1.76%, utility model cases decreased by 1.84% and design cases increased by 8.93%. The total trademark applications accounted to 86,794, with an increase of 2.33%. The key statistics are provided in the following tables.

As can be seen from above, TIPO average examination times for 2019 patent and trademark applications were within 14 months and 7 months, respectively. Generally, applicants can obtain patent and trademark protection faster in Taiwan as compared to other countries. Especially for an invention patent application, the applicant can file a request with TIPO to expedite the examination via AEP (Accelerated Examination Program) or PPH (Patent Prosecution Highway). For trademark application, there is an accelerated examination measure in proposed Trademark Act Amendment which TIPO submitted on November 26, 2019 for public consultation and it may be enforced from late 2020 or in 2021 if passed by Legislative Yuan.
