- Base 2 an invention application that has a corresponding foreign application pending before USPTO, JPO or EPO, but official action and search report have been issued
- Base 3 an invention application required for commercial practice
- Base 4 an invention application related to green technologies
- *PPH refers to Patent Prosecution Highway program. Currently there are PPH bilateral agreement between TIPO and USPTO, JPO, KIPO, SPTO, PPO and CIPO, respectively.

Remarks:

For an invention patent application rejected in the primary examination phase, merely due to part of the claims not being patentable, if the Applicant files a request for re-examination by deleting the rejected claims (or filing divisional application) or by rewriting the non-rejected dependent claims into independent claims, then TIPO may issue a first office action or decision on the re-examination application within six months.
